CLEARING THE AIR: FACTS ABOUT SECONDHAND SMOKE

Secondhand smoke (SHS) comes from cigarettes, some plant-based products (such as marijuana), vapes, cigars, pipes, and hookahs.

There are more than 7,000 chemicals present in SHS. 1

People who do not smoke but are exposed to SHS, are breathing in many of these same chemicals, including 50 known to cause cancer.



It is unhealthy to breathe any amount of tobacco smoke.^{1,4}

Secondhand aerosol from e-cigarettes/ vapes has harmful chemicals that can cause cancer and damage lungs.⁴ Exposure to SHS is harmful to high-risk populations such as children, people with asthma, older adults, and pregnant women^{2,3}
